--- *The President's Message* ---

Spring started early this year, in February, with the NYSUT Regional Conference held at the Cradle of Aviation Museum in Garden City. About 300 people from both Nassau and Suffolk attended and we were brought up to date on Legislation, Benefits, Insurance, Retirement, and issues confronting our teachers today. These areas were addressed by Kathleen Donahue, NYSUT VP, David Keefe, Retiree Trust for the NYSTRS Board, and other Department Coordinators from the Albany office. They also provided a breakfast and lunch as well as guided tours of the museum. It was a great way to start the new year!

I recently returned from attending the NYSUT Representative Assembly in Washington, DC. The theme for this year was "VOICE" in all its iterations. Delegates were urged to use their voices in debating issues, celebrating our accomplishments, and protesting injustices. We also heard the voices of many children, from an elementary school, singing songs about learning, friendship, and nutrition.

Speaker, NY Senator Chuck Schumer, was introduced as the "staunchest ally and advocate of NYSUT and public schools in the U.S. Senate". His speech in support of teachers, and the public school system which he and his family attended, brought the delegates to their feet with praise. At one point, he said "It makes no sense to degrade, to belittle the most important profession in America".

We heard from State Education Commissioner John King who spoke briefly and then opened the floor to a Q&A session, which was lengthy. Many teachers had angry questions regarding the Common Core Curriculum-based exams being given this spring. Instruction in this curriculum only started in the fall. He replied that "these assessments are an opportunity to see how we do against something that is challenging ... after all, we want students to become adults who are courageous about taking challenges".



NYSUT VP Maria Neira gave a fiery call to action and to take our frustrations and anger to the streets. She told delegates that the SED's obsession with testing is "just the tip of the iceberg". This is "about testing becoming big business! It's about silencing our professional voice and the privatization of public education."

NYSUT President Dick Iannuzzi spoke of the outpouring of 10,000 e-mails, The Tell It Like it Is Forums, and the many petitions circulated. He referenced the Fiftieth Anniversary of Martin Luther King's March on Washington and said that we will have a "March" to Albany on June 8th. The hope is that most of our members will try to attend. If several thousand NYSUT members – active and retired – come out and use their VOICES, we will be heard. Buttons were distributed to all bearing the message "I'LL BE THERE 6.8.13". More details regarding transportation, etc., will be coming. Stay tuned.

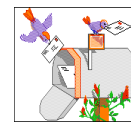
Our Vote/Cope contributions were such that HHHART received the Abel Blattman award for 2012.

Know Your HHHART Board

Our interviewee this issue is **Sandy Glickman**, who is a publisher of the *HHHART Beat*



I was born and spent my first twenty years in the Bronx, except for three months, in Hermosa Beach, CA when I was eleven. Our family members recently discussed and all do agree that they had a wonderful school experience, with exceptional teachers and courses.

I started teaching in Half Hollow Hills as a sub. In 1972, I was ready to go back to teaching full time, and I was fortunate to get a position as a

Reading Teacher. That was my career for twenty-three years, and I loved it - the teaching, the learning, the students, and my colleagues (and Principals in Taukomas and Forest Park) in the Reading departments of the other schools. 3. Household cleaners
4. Mouse & rat poison
5. Paints & varnishes

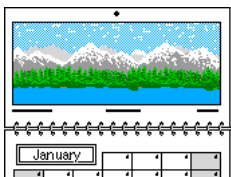

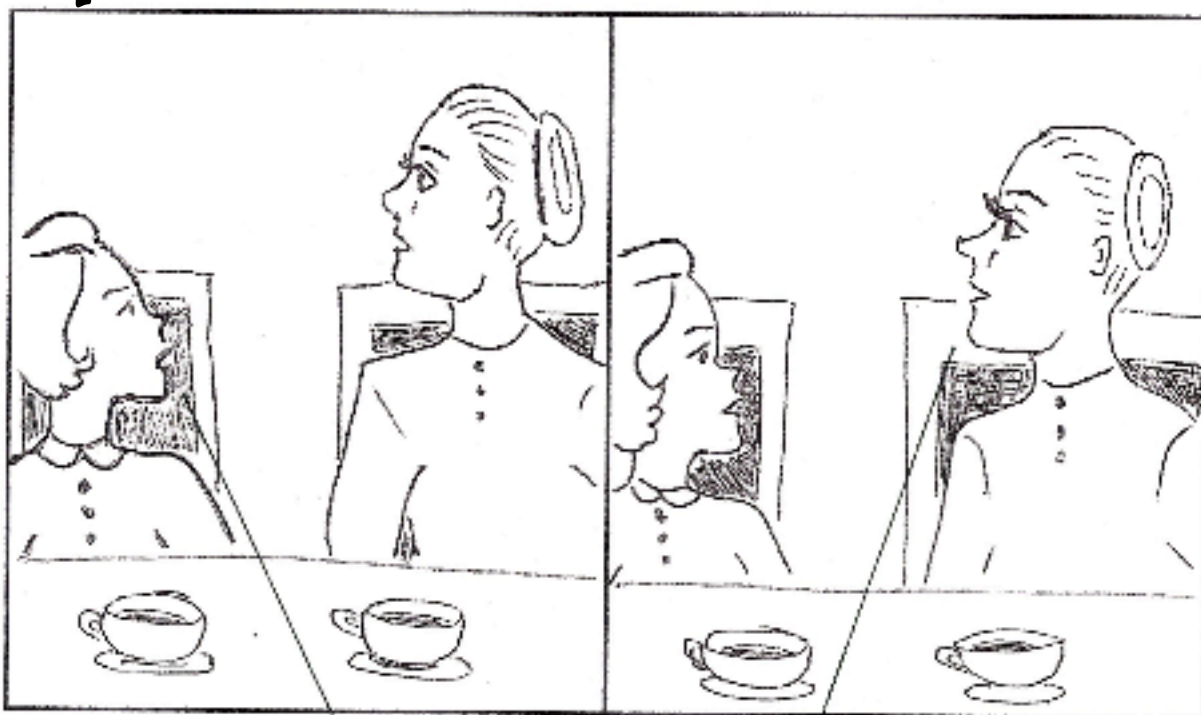
