## --- The President's Message ---

I'm sure you have all heard the claim that public employees' pensions are bankrupting states, including The recent exposé York. of school Superintendents' salaries and retirement packages did nothing to help the situation. As you know, our state pension systems are well run and cost effective. Because of that, the current employer contribution rate is among the lowest of all 50 states. consecutive years in which the school districts' contribution rate was less than 2% of payroll and in which there were few critics of public pensions, the cost has increased because of economic changes beyond anyone's control. The cost would be much higher if the plan did not operate so efficiently or invest so successfully. Many teachers consider their pensions as a benefit in lieu of salary. Statewide median salaries for teachers are still less than what other professionals with a Master's degree and 20 years of experience earn in The pension system helps the private sector. promote teaching as a career. And as NYS residents, we all contribute to public pensions!

Teacher layoffs are happening everywhere. Even HHH has notified about 14 teachers of this impending action. And now, in response to NYC, Albany has passed a Seniority Bill which targets NYC teachers. This eliminates the LIFO seniority laws (Last In First Out). This law has implications for the entire state. Mel refers to this as "a line in the sand to us". We fought long and hard to gain this right and we will not lose it.

Social Security remains under attack. A new technique for those congressmen seeking to cut back on those benefits, as well as Medicaid and Medicare, is the news that they have cut \$1.7 billion from the SS administration fund. This means closing SS offices, firing employees who run the system and reducing all costs to administer it. All services would be slowed down and delayed including benefit checks for all recipients.

And then there is the situation in Wisconsin. Eliminating public employees' collective bargaining rights strikes at the heart of the unions. Some of you may remember when we did not have those rights or any others and had to plead for any improvements in our working conditions and for our students. Have you seen this Wisconsin tweet? "If u live in Wisconsin, don't forget to set your clock back 50 years this weekend". How true. Those people are to be commended for their persistence and dedication in fighting for their rights. After their Governor Walker and a handful of Republican senators circumvented the law and passed the bill busting their public worker unions you might have expected that the protesters would have packed up and gone home. But not those folks. 85,000 to 100,000 amassed in the capitol in a completely peaceful demonstration, joined by 50 farmers on tractors, to begin the process of redress. This will take the form of legal challenges to the vote on the bill and recall for the 16 senators involved. Gov. Walker's turn will not come up until next January when he has been in office for 12 months.

Twelve other states have similar legislation pending or proposed.

So what can you do about all this? If you've never participated in social action, or political action, now is the time to start. We are not only working for our own benefits, but for all the current teachers and those to come, and for all the children who will be affected in Call or write or fax your state our schools. representatives and the governor. Write letters to the newspapers. Attend the many rallies that are being held all over the state. ## Welfare Trust Benefits by Dick Lee, Trust Fund Administration

Many of our younger retirees get confused with how their medical coverage is affected once they become Medicare eligible. I've even heard some long time retirees asking why they receive a check from the District twice a year. To try to explain how Medicare coverage works with your NYSHIP (Empire) coverage, Barry Corbett has developed an easy to understand fact sheet on the subject:

Medicare Part A ---- covers Hospital Charges All members of the US workforce pay for Medicare Part A throughout their careers. They are automatically enrolled by the Government upon attainment of age 65 regardless of employment status.

## Medicare Part B----covers Medical Charges (Doctor/Surgeons)

NYSHIP (New York State Health Insurance Program) requires ALL enrollees who are retired and attain age 65 to enroll in Medicare Part B.

Here is how it usually works — after you are retired and on Medicare—you go to the doctor for a physical — he sends the bill to Medicare — they usually pay about 80%. Medicare then sends it to United Healthcare — they pay the difference. United Healthcare then sends you an EOB (explanation of benefits) showing what Medicare paid, what they paid, and what you owe — usually a \$20 Co Pay to the Dr's office.

Medicare Part B is not free – the Government (Social Security Administration) charges \$96.40 – \$110.50 per month (referred to as the base amount).

If you are collecting Social Security benefits the charge will come directly out of your monthly allotment, If not, they will bill you directly.

Since NYSHIP requires that you and /or your spouse enroll in Medicare Part B, they require the district to reimburse you for the cost. Our district reimburses our retirees for the base amount on a semiannual basis – once in January and once in July.

At the end of the calendar year, the Social Security Administration sends out an SSA 1099.

This document reflects the amount of SS payments remitted to you and the total amount of Medicare Part B Premiums that were deducted. Any amount of Med B premiums charged above the base amount and not reimbursed by the district will be reimbursed in a third check upon receipt by the district of a copy of the enrollee and/or enrollee's spouse's SSA 1099.

Hopefully this explanation helps you better understand the complexities of healthcare coverage once you and your spouse or significant other\* becomes Medicare eligible.

\*As of July 1, 2010, the District provides health coverage for significant other and same sex relationships. To apply for such coverage call Barry Corbett at 631-592-3094 for further information and an application. Be sure to consult with your tax advisor and discuss the taxation relative to adding a same sex partner through marriage or domestic partnership.






